

1. Environmental Sustainability Policy Statement

We at Wren Kitchens Ltd, take our responsibilities for Environmental Sustainability very seriously.

5. Legal Requirements

The Climate Change Act 2008 set legally binding targets for the UK to reduce greenhouse gas emissions by at least 34% by 2020 and at least 80% by 2050 (both targets against a 1990 baseline).

Environmental Protection Act 1990

The Environmental Protection Act 1990

The three key areas are summarised below:

- Part 1 Integrated Pollution Control and Local Authority Air Pollution Control This section focuses on preventing & reducing the release of substances into the environment.
- Part 2 Waste on Land. This section puts a prohibition on unauthorised or harmful deposit, treatment or disposal of waste, placing a Duty of Care on the organisation to prevent escape of harmful substances.
- Part 3 Statutory Nuisances and Clean Air requires the Local Authority to regularly inspect the area and to deal with problems such as Smoke, Fumes, Dust, Smell, Noise, and animals.

Environmental Protection Act 1995

This Act was instrumental in creating the Environment Agency and it deals with the following:

- Air Quality
- Water Quality
- Contaminated Land
- Waste

The Waste Electrical and Electronic Equipment (WEEE) Directive

This came into force in January 2007 and aims to both reduce the amount of Electrical and Electronic waste being produced and encourage everyone to reuse, recycle and recover it. The categories of items which covered by the Wren WEEE and RoHS directives are:

- IT and Telecoms Equipment
- Consumer Equipment
- Lighting Equipment
- **Flectrical and Flectronic Tools**
- Medical Devices

Environmental Permitting Regulations 2010

The Environmental Permitting Regulations (England and Wales) 2010 were introduced on 6 April 2010 and replace the 2007 Regulations.

These regulations cover the storage, treatment, transport and disposal of hazardous waste.

The Waste Framework Directive

The Waste Framework Directive requires member states to ensure that waste is recovered or disposed of without endangering human health and without using processes and methods which could harm the environment.

Energy Savings Opportunity Scheme (ESOS)

Under EU legislation it became mandatory for UK companies to complete an initial audit of their energy usage. The audits which are carried out by third parties, will result in energy saving recommendations, implementation of which is optional.

6. Procedure

Wren Kitchens Ltd, will deliver the aims and objectives of the policy through the following key areas:

Environmental and Sustainable Management:

- Develop and review sustainability targets against appropriate benchmarks.
- Monitor energy consumption against past performance.
- Communicate and promote environmental and sustainability procedures, regulations and initiatives at staff inductions and training sessions.
- Encourage and facilitate feedback and suggestions from stakeholders to improve good practices.
- Exchange best practice with industry experts, local authorities and other organisations.
- Integrate environmental and sustainability principles into the Wren operational procedures and decision-making process.

Carbon Management:

- Develop a Carbon Management Plan setting clear targets for carbon reduction, identify initiatives to achieve the target and key stakeholders responsible for delivery.
- Implement working practices to ensure the efficient use of energy at all Wren sites.
- Incorporate low carbon technology and renewable energy systems in building projects and equipment procurement.
- Improve the energy efficiency of existing buildings.

Net Zero Carbon Initiative:

Wren Kitchens have embarked on a Net Zero Carbon Initiative in partnership with the university of Hull and Carbon Visibility Ltd, the initial aspects of this initiative will allow Wren to identify our CO2 footprint upstream, downstream and throughout our operation, in order to establish a carbon reduction plan.

Estates and Facilities

- Enhance biodiversity within the Wren sites where possible.
- Manage noise pollution to ensure minimal impact on neighbours and the natural environment.

Waste Management:

- Minimise waste and reduce consumption through efficient operational use of assets.
- Minimise the environmental impact of waste through appropriate re-use and recycling.
- Measure and monitor waste.
- Segregate waste to achieve zero waste to landfill.
- Develop working practices to reduce waste and prevent pollution.

Water:

- Manage clean, ground and wastewater efficiently including recovery and recycling opportunities.
- Our purchasing team are in the process of gaining Chartered Institute of Procurement and Supply's "Ethical Procurement & Supply" status.
